Parent Contract

I hereby pledge to provide positive support, care and encouragement for my child participating in the GCS by following this Parent/Guardian Code of Conduct:

1. I will encourage good sportsmanship by demonstrating positive support for all participants, coaches, and board members at any of The Galveston County Seahawk Football (GCS) event.
2. I will demand an environment for my child that is drug free and alcohol free at all team and league events. I will not consume alcohol, drugs or smoke at any team or GCS event. I will not attend any team function or game under the influence of alcohol or a controlled substance.
3. I will supervise my child in the program and any other children I bring to the field. This includes all practices, team functions and games.
4. I will instruct my child to treat other participants, coaches, board members, parents and spectators with respect regardless of race, sex, creed, religion, national origin or athletic ability.
6. I will refrain from any vulgar, lewd or obscene language or gestures while participating in, or watching any team or league sponsored GCS event. I understand that I am responsible for the behavior of any guest that attends a team or league function with me.
7. If I wish to direct comments or criticisms toward any parents, coaches, or board members I agree to do so out of the view or hearing range of the children participating in the league. I agree to conduct myself in a calm, civilized manner when communicating with said person. I agree to correspond with said person at an appropriate time, not when they are coaching or in the middle of other activities.

8. All Property of the GC Seahawks will be returned upon request or theft charges will be filed.

9. ALL COMMUNICATION WILL BE DISTRIBUTED THROUGH EMAIL, IF ANY CONTACT INFORMATION IS CHANGED, THE GC SEAHAWKS WILL BE NOTIFIED

Refund Policy: If a player is unable to participate for any reason the fee will be considered as a contribution to the team. A receipt can be provided to claim the contribution for tax purposes.

It is understood that execution of this contract means that my child is committed to the GCS for the season. It is understood that violation of any part of this contract are grounds for my expulsion, and potentially my child's removal, from GCS activities. The GCS staff and board members have the exclusive right to enforce violations.
